PROJECT RISE PRO-BONO PROGRAMME

OFFICIAL TERMS AND CONDITIONS

These Official Terms and Conditions ("**Terms and Conditions**") apply to the Project RISE Pro-Bono Programme (the "**Initiative**") sponsored by Weber Shandwick UK, in partnership with The Black British Business Awards Enterprise Academy ("**BBBA**").

1. APPLICATION PERIOD.

The Initiative application period commences on Wednesday 7 July, 2021 at 12:00:00 a.m. (midnight) British Summer Time (BST) and closes on Tuesday 31 August, 2021 at 11:59:59 p.m. British Summer Time (BST) (the "**Application Period**").

2. HOW TO APPLY.

To apply to the Initiative, submit the online application form available at

https://www.thebbbawards.com/rise-up-programme (the "**Application**") during the Application Period. Applications will be accepted by online entry only. All Application information will be kept confidential. Applicants must fully complete, submit, and upload all information requested in the Application, as directed, before the end of the Application Period in order to be considered for the Initiative. Limit one (1) Application per person/email address/business. All Applications must include a valid email address and phone number for the applicant. Applications that do not comply with these Terms and Conditions and/or are incomplete or inaccurate may not be eligible for consideration. By submitting an Application, applicants represent that the materials submitted are original and have been created by the applicant and/or that all necessary rights have been secured and disclosed in the event they were developed by others.

3. ELIGIBILITY.

- A. To be eligible for the Initiative, applicants and their respective businesses must meet all of the eligibility criteria as set out in the Application:
- B. Employees, officers and directors of Weber Shandwick UK, BBBA, and each of their respective parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers and distributors of promotion materials, and their immediate families (parents, children, siblings, spouse) and members of the same household (whether related or not) of such employees, officers and directors are not eligible to apply to the Initiative.
- C. No purchase or payment of any kind is required to apply to the Initiative. Neither a purchase of Weber Shandwick's or BBBA's services nor a payment of any kind to any of the foregoing will improve your chance of selection for the Initiative. This Initiative is subject to all applicable UK laws and regulations and is void where prohibited by law.

4. THE AWARD.

A. Up to GBP £20,000.00 worth of Weber Shandwick UK's consultancy time and services will be awarded to each of the five (5) final recipients (the "Recipients"), to be used within 12 months for communications services which include but are not exclusive to: media relations, social media, executive communications and creative (the "Services"). The final Services are to be directed / confirmed by Weber Shandwick UK. The individual value and nature of the Services will depend on

the application of the selection criteria set forth in Section 5 below, as well as a Recipient's need and business strategy, as the Committee may determine in its sole discretion after consultation with such Recipient. A budget and outline of deliverables will be agreed at the outset of the work commencing, with any additional costs agreed in advance with each Recipient. By applying to the Initiative, applicants agree that, if selected as a Recipient, applicants will use the Services solely for legitimate business purposes.

B. The Award is non-transferable and non-assignable. No substitutions or cash redemptions are permitted. Weber Shandwick UK reserves the right, in its sole discretion, to increase the value of any Award. If no or an insufficient number of Applications meet the minimum eligibility criteria, some or all of the Awards may not be awarded, or Weber Shandwick UK may increase the value of any awarded Services. Weber Shandwick UK reserves the right, in its sole discretion, to substitute a prize of equal or greater value if the advertised Award becomes unavailable.

5. HOW RECIPIENTS ARE DETERMINED.

- A. Eligible Applications will be reviewed by members of a committee consisting of nine (9) judges, including an internal panel of Weber Shandwick UK employees, one or more BBBA employees and other independent senior communications professionals (the "**Committee**"). The Recipients will be selected from among all eligible applicants based on the following criteria:
 - i. Achievements, business success and potential to scale
 - ii. How well the business was able to articulate their communications problems
 - iii. How engaging the businesses' story/product is based on their applications, referencing concrete examples they give
 - iv. The level of impact the business has had on the industry to-date, referencing concrete and data focused examples they have given
 - v. The extent to which the Judges perceive the business to be an innovator in their specific industry, referencing concrete examples they have given
 - vi. The level of impact the Judges think the business could have on the industry. Could they be game-changing?
- B. Weber Shandwick UK will make all reasonable efforts to contact each Recipient promptly upon selection of each such Recipient. If a Recipient cannot be contacted or is not available, or has not claimed their prize within fifteen (15) business days of the Recipient announcement date or first contact date from Weber Shandwick UK to the Recipient informing the Recipient of their successful application, Weber Shandwick UK reserves the right to offer the relevant Award to the next eligible entrant selected from the correct entries that were received before the Closing Date. If Weber Shandwick UK so elects, potential Recipients may be required to submit to a confidential background check. Such background check may include (but is not limited to) investigation of criminal and sexual offenses, or other arrest or conviction records, and any other factors deemed relevant by Weber Shandwick UK to help ensure that the potential Recipient will not bring Weber Shandwick UK into public dispute, contempt, scandal, or ridicule or reflect unfavorably on Weber Shandwick UK.
- C. For the avoidance of doubt, neither Weber Shandwick nor the Committee are under any obligation to reveal the degree of consideration it may have given any Application, vetting communications

and/or other forms, including, but not limited to, stating any reason for rejection, or to return any Application material to any applicant.

6. PRIVACY.

Any information provided by applicants as part of the Application process or otherwise in connection with the Initiative will be processed in accordance with Weber Shandwick UK's privacy policy, available at https://www.webershandwick.com/privacy-policy/#content-8. See also section 7 below with regard to the announcement of winners.

7. CONFIDENTIALITY & PUBLICITY.

- A. All non-public business and financial information applicants provide as part of their Application will be kept confidential. By submitting an Application and participating in the Initiative, applicants acknowledge and agree that, if they are selected as a Recipient, they will not disclose to any person or third party the fact that they were selected until notified by Weber Shandwick UK that such disclosure is permitted or until made public by Weber Shandwick UK. Weber Shandwick UK will coordinate all publicity and press announcements regarding the Initiative and will provide Recipients with as much advance notice of such announcements as reasonably possible. Weber Shandwick UK may refuse any media opportunity in its sole discretion. By participating in the Initiative, each Recipient agrees to the use by Weber Shandwick UK and/or its designees of its name, image, likeness, logo and/or biography as provided for programming, advertising, publicity and promotional purposes in connection with the Initiative in any and all media, now or hereafter known, worldwide and on the Internet, in perpetuity, without compensation (unless prohibited by law) or additional consents from Recipient or any third party and without prior notice, approval or inspection. Upon request by Weber Shandwick UK, Recipients agree to promptly execute and deliver to Weber Shandwick UK any documents reflecting the foregoing.

8. LIMITATION OF LIABILITY.
